CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MARTHA J. HOSMER & GRANT MATHEWS

of Gold Hill, State of Oregon, 97525, has
a right to the use of the waters of Right or West Fork of Foot's Creek

a tributary of Rogue River for the purpose of
irrigation of 7.5 acres in Tract No. 1, and Placer Mining, November 1st to May
1st in Tract No. 2

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the
right thereby confirmed dates from 1857 for Tract No. 1, 1867 for 5.0 cubic feet per
second and 1898 for 10.0 cubic feet per second for Tract No. 2;
that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per
second for Tract No. 1, and 15.0 cubic feet per second for Tract No. 2


This certificate describes that portion of the water right confirmed by the prior
