CERTIFICATE OF WATER RIGHT

This Is to Certify, That

J. E. FERRARE & C. O. BOOTH

of Williams, State of Oregon, 97544, has
 a right to the use of the waters of Williams Creek

a tributary of Applegate River for the purpose of
 supplemental irrigation of 58.8 acres, stock and domestic use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1891

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.98 cubic foot per second, and shall be limited to the amount of water available at the original point of diversion for the Sparlin-Bigelow Ditch, which water is not available at the original points of diversion for the Baltimore Ditch

The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 23 and NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 26, as projected within the Shoudy DLC 38, T. 38 S., R. 5 W., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:


This certificate is issued to supersede certificate of water right recorded at page 47909, Volume 41, State Record of Water Right Certificates so as to correct the place of use.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
