CERTIFICATE OF WATER RIGHT

This Is to Certify, That PRINCE V. & IRENE M. BAKER

of Rt. 1, Box 417, Monroe, State of Oregon, 97456, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Muddy Creek

a tributary of Mary's River for the purpose of irrigation of 188.0 acres

under Permit No. 41181 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 14, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Kelsey DLC 56, Section 20, T. 14 S., R. 5 W., W. M., No. 1-600 feet South and 1900 feet West; No. 2-1260 feet South and 2320 feet West from the NE Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


