CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM & HAZEL KENNEDY

of Rt. 2, Box 47, Scappoose , State of Oregon, 97056 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of spring and two creeks

a tributary of Scappoose Bay for the purpose of domestic use for one family, shop use, stock use, and irrigation of 2.5 acres

under Permit No. 37302 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 12, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.027 cubic foot per second, being 0.005 c.f.s. for domestic, 0.005 c.f.s. for shop and 0.007 c.f.s. for stock from spring, and 0.005 c.f.s. from Creek No. 1 and 0.005 c.f.s. from Creek No. 2 for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Spring and Creek No. $1-SW_2$ SW $_2$, as projected within Laffer DLC 43, Section 30, T. 4 N., R. 1 W., W. M., Creek No. $2-SE_2$ SE $_2$ as projected within Laffer DLC 38, Section 25, T. 4 N., R. 2 W., W. M., spring-1120 feet North and 18 feet East; Creek No. 1-1334 feet North and 329 feet East; Creek No. 2-1115 feet North and 244 feet West, all from the SE Corner, Section *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic, Shop & 1.2 acres SW4 SW4 As projected within Laffer DLC 43 Section 30 T. 4 N., R. 1 W., W. M.

Shop, Stock & 1.3 acres SE4 SE4 As projected within Laffer DLC 38 Section 25
T. 4 N., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
