a tributary of Pudding River irrigation of 184.0 acres

for the purpose of

under Permit No. 13619 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 25, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.30 cubic feet per second, if available at the original point of diversion; SW4 NW4, Section 24, T. 6 S., R. 1 W., W. M., Walker Ditch-53.5 chains South and 33.0 chains East from the NW Corner, S. Allen DLC 50

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE^{1}_{4} NE $^{1}_{4}$, Section 23, T. 6 S., R. 1 W., W. M., 2330 feet South and 560 feet East from the most southerly SW Corner, Gibson DLC 54

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre. Or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
