a tributary of Willamette River irrigation of 56.2 acres

for the purpose of

under Permit No. 21841 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 10, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.60 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SE $\frac{1}{2}$ NN $\frac{1}{4}$), NE $\frac{1}{4}$ SN $\frac{1}{4}$, as projected within Aldridge DLC 50, Section 26, T. 9 S., R. 6 W., W. M., Diversion No. 1-430 feet North and 320 feet West; Diversion No. 2-1300 feet West and 330 feet South, both from the Center, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre. or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
