of Rt. 1, Box 629, Dundee , State of Oregon, 97115 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Yamhill River

a tributary of Willamette River irrigation of 60.2 acres

for the purpose of

under Permit No. 36861 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second, if available at the original point of diversion; SE½ SE½, as projected within Alderman DLC 43, Section 9, T. 4 S., R. 3 W., W. M., 4530 feet South and 10 feet West from the NE Corner, Section 9

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, as projected within Alderman DLC 43, Section 16, T. 4 S., R. 3 W., W. M., 1500 feet South and 1030 feet West from the NE Corner, Section 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
