CERTIFICATE OF WATER RIGHT

This Is to Certify, That M.N. LOUGHRIDGE et al.

of Murphy, State of Oregon, 97533, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of irrigation of 207.8 acres

under Permit No. E-40 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.60 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

POINTS OF DIVERSION

Tract No. 1 - SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 35, 1240 feet North and 1300 feet East from the W $\frac{1}{4}$ Corner, Section 35;

Tract No. 2 - NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 28;

Tract No. 3 - SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 20, 3700 feet North and 1485 feet West from the SE Corner, Section 20;

Tract No. 4 - SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 27, portable pump;

Tract No. 5 - SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 21, 600 feet North and 875 feet West from the SE Corner, SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 21;


This certificate describes the water right confirmed by the prior certificate recorded at page 444, Volume 1, State Record of Water Right Certificates, as modified under the provisions of orders of the Water Resources Director entered on June 2, 1923, approving a petition for change in point of diversion; on September 10, 1948, approving transfer application No. C-75 for change in point of diversion; on July 11, 1957, approving transfer application No. S-110 for changes in point of diversion and place of use; and on August 23, 1961, approving transfer application No. S-137 for change in point of diversion; EXCEPT for that portion of said water right modified by the provisions of an order of the Water Resources Director entered on August 18, 1977, approving transfer application No. 3436.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
