## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** HARRY H. AND WINONA M. WEATHERLY

of 25967 Kruger Park Rd., Junction City, State of Oregon, 97448, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fern Ridge Reservoir constructed under permit No. R-1625

a tributary of Long Tom River for the purpose of irrigation of 6.7 acres

under Permit No. 36943 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5, T. 17 S., R. 5 W., W. M., 430 feet South and 1200 feet East from the C $\frac{1}{2}$  Corner, Section 5; Fern Ridge Reservoir - NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 4, T. 17 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to-----of one cubic foot per second per acre, a diversion of 2 $\frac{1}{2}$  acre feet for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of contract No. 14-06-100-7780 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
 2.7 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
 1.3 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
