CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONOVAN L. NICOL

of 212 Williams Bldg., Klamath Falls, State of Oregon, 97601, has made proof to the satisfaction of the Water Resources Director of a right to the use of the waters of Lenz Creek, sometimes called Big Springs Creek

a tributary of Williamson River for the purpose of irrigation of 1000 acres

under Permit No. 7374 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1926

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 12.5 cubic feet per second; if available at the original point of diversion; NW $\frac{1}{2}$ NE $\frac{1}{2}$, Section 27, T. 30 S., R. 8 E., W. M., 1595 feet West from the NE Corner, Section 27

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{2}$ NW $\frac{1}{2}$, Section 35, T. 30 S., R. 8 E., W. M., North 48 degrees 54.25 minutes West, 4377.7 feet from the SE Corner, Section 35

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:



This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered August 25, 1964 and together with certificate of water right recorded at page 31725, Volume 23, State Record of Water Right Certificates supersedes certificate of water right recorded at page 9120, Volume 9, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
