CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. JUSTIN SNYDER

of Enterprise , State of Oregon, 97828 , has
a right to the use of the waters of
Wallowa River

a tributary of Grande Ronde River for the purpose of
irrigation of 148.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Wallowa County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 5 , at page 206, 207, that the priority of the
right thereby confirmed dates from and 208
September 10, 1901

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per
acre during any period of 30 days prior to July 31st of each year, and there-
after not to exceed 1 acre foot per acre during the entire remainder of the
irrigation season; if available at the original point of diversion Wrenn -
Dobbins Ditch, NE¼ NE¼, Section 31, T. 2 S., R. 45 E., W. M.
The point of diversion is located in the
SE¼ SE¼, Section 12, T. 2 S., R. 44 E., W. M., 1310 feet North and 350 feet
West from the SE Corner, Section 12

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

40.0 acres SW¼ NW¼


This certificate is issued to confirm a change in point of diversion approved
by an order of the Water Resources Director entered January 30, 1978 and
together with certificate of water right recorded at page 45343, Volume 37,
State Record of Water Right Certificates supersedes certificate of water right
recorded at page 3198, Volume 4, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of
the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
