## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of 15234 Butsch Lane N.E., Mt. Angel , State of Oregon, 97362 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 1 & No. 2

a tributary of Pudding River irrigation of 152.5 acres

for the purpose of

under Permit No. G-6628 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 30, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.91 cubic feet per second, being 1.22 cubic feet per second from No. 1 and 0.69 cubic foot per second from No. 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NN $\frac{1}{4}$  SN $\frac{1}{4}$ , Section 34, SN $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 34, both as projected within Rondeau DLC 47, T. 5 S., R. 2 W., W. M., No. 1-50 feet South and 1200 feet East from the N $\frac{1}{4}$  Corner, Section 34, No. 2-1150 feet North and 840 feet East from the S $\frac{1}{4}$  Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
