CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ERNEST SHIPPEN AND JACK HERT

of Rt. 1, Box 180, Roseburg, State of Oregon, 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Deer Creek

a tributary of South Umpqua River for the purpose of irrigation of 1.11 acres

under Permit No. 3838 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1918 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.014 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Howe DLC 45, Section 20, T. 27 S., R. 5 W., W. M., No. 1-20 feet North and 50 feet East; No. 2-10 feet North and 180 feet East, both from the SW Corner, Howe DLC 45

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to confirm changes in points of diversion approved by an order of the Water Resources Director entered October 30, 1968 and to correctly describe the place of use and together with certificate of water right recorded at Page 47893, Volume 41, State Record of Water Right Certificates supersedes certificate of water right recorded at Page 5018, Volume 5, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
