under Permit No. 15999 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shell not exceed 0.293 cubic foot per second, if available at the original point of diversion, SE $_4$ SE $_4$, as projected within Ollivant DLC 51, Section 28, T. 28 S., R. 7 W., W. M., 300 feet North and 1275 feet West from the SE Corner, Section 28

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $_4$ SE $_4$, as projected within Ollivant DLC 51, Section 28, T. 28 S., R. 7 W., W. M., 850 feet North and 840 feet West from the SE Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
