## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** LEWIS VINCENT KESLER

of 2545 Cedar Flat Road, Williams, State of Oregon, 97544, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of West Fork of Williams Creek

a tributary of Williams Creek for the purpose of irrigation of 19.25 acres

under Permit No. 4886 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 15, 1920

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second, if available at the original diversion points of record; Hoxie Ditch - (NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 8) and SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5, 510 feet North and 400 feet West from the SE Corner, Section 5, both T. 39 S., R. 5 W., W.M.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5, T. 39 S., R. 5 W., W.M., 440 feet North and 640 feet West from the SE Corner, Section 5

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.25 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 5


This certificate is issued to confirm changes in points of diversion approved by an order of the Water Resources Director entered July 7, 1976 and together with certificates of water right recorded at page 42157, Volume 34, page 43769, Volume 35, and page 48670, Volume 42, State Record of Water Right Certificates, supersedes certificates of water right recorded at page 3316, Volume 4 and page 36487, Volume 28, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
