CERTIFICATE OF WATER RIGHT

This Is to Certify, That LARRY T. MCVEY

of 845 Meadow View, Williams, State of Oregon, 97544, has
a right to the use of the waters of West Fork Williams Creek

a tributary of Williams Creek for the purpose of
domestic use for one family and irrigation of 4.6 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the
right thereby confirmed dates from 1875.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.085 cubic foot per
second, being 0.005 c.f.s. for domestic use and 0.08 c.f.s. for irrigation, if
available at the original point of diversion; NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, T. 39 S., R.
5 W., W. M., Chapman Ditch-440 feet South and 1200 feet West from the E $\frac{1}{4}$ Corner,
Section 4.

The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 3, T. 39 S., R. 5 W., W. M.,
740 feet North and 1110 feet West from the Center, Section 3.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

2.9 acres Lot 18
0.2 acre Lot 19
SW $\frac{1}{4}$ NW $\frac{1}{4}$
Domestic & 1.5 acres Lot 19
SE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 3
T. 39 S., R. 5 W., W. M.


Note: Lots within forty acre tracts refer to Retzloff partition of the NW $\frac{1}{4}$ of
Section 3, T. 39 S., R. 5 W., W. M., recorded in Josephine County.

This certificate is issued to confirm a change in character of use and point of
diversion approved by an order of the Water Resources Director entered February
15, 1977 and together with certificate of water right recorded on Page 47914,
Volume 41, State Record of Water Right Certificates and an order of the Water
Resources Director entered on February 15, 1977 approving transfer application
No. 3411 supersedes certificate of water right recorded on Page 43766, Volume
35, State Record of Water Right Certificates.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
