CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ALBERT HAZEN

of 3215 West 12th, The Dalles , State of Oregon 97058 , has a right to the use of the waters of Mill Creek and springs

a tributary of Columbia River for the purpose of irrigation of 14.8 acres, supplemental irrigation of 2.3 acres and domestic purposes

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at page 119; that the priority of the right thereby confirmed dates from 1865

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second from Mill Creek, if available at the original points of diversion; Hazen Ditch - NE½ SW½, Section 22 and Hazen South Side Ditch - NW½ SE½, Section 22, T. 1 N., R. 12 E., W.M., and further limited to a diversion of not to exceed one—sixtieth of a cubic foot per second per acre during the irrigation season from*

The point of diversion is located in the Springs - NE½ NE½, SW½ NE½, Section 22; Mill Creek - SE½ NE½, Section 22, T. 1 N., R. 12 E., W.M., 300 feet North and 1240 feet West from the E½ Corner, Section 22

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

11.6 acres SE½ NE¾
Section 22

Springs domestic and 2.3 acres SE¼ NE¼ Section 22 T. 1 N., R. 12 E., W.M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 5697, Volume 6, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on July 21, 1965, approving transfer application No. H-159 and is issued to confirm changes in points of diversion from Mill Creek approved by the same order and supersedes certificate 5697.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

*April 1st to October 1st and 0.04 c.f.s. from springs for supplemental irrigation and a reasonable amount for domestic purposes

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
