CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLARENCE E. QUIRK

of 716 W. Ninth, The Dalles, State of Oregon, 97058, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fifteenmile Creek

a tributary of Columbia River for the purpose of irrigation of 53.0 acres

under Permit No. 26700 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 14, 1960 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.54 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 31, T. 2 N., R. 15 E., W.M., 2350 feet North and 3060 feet West from E $\frac{1}{2}$ Corner, Section 31 and 40 feet South and 2300 feet East from NW Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 32363, Volume 24, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on November 5, 1969, and June 4, 1976, approving transfers numbered Q-4 and 3414 and is issued to confirm a change in point of diversion and place of use approved by the same orders and supersedes certificate 32363.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
