## CERTIFICATE OF WATER RIGHT

This Is to Certify, That LORIS A. WILLETT

of Route 1 Box 2050, Bandon, State of Oregon 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and Bandon Reservoir constructed under Permit No. R-628U

a tributary of China Creek for the purpose of supplemental irrigation of 2.0 acres of cranberries, frost control and harvesting cranberries under Permit No. 39195 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 20, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.3 cubic foot per second, being 0.05 c.f.s. for irrigation and 0.3 c.f.s. for frost control from stream and 0.1 c.f.s. for harvesting from stream and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) Section 7, T. 29 S., R. 14 W., W.M., 880 feet North and 330 feet East from the SW Corner, Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

cranberry irrigation, frost control and harvesting  
2.0 acres Lot 3 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 7  
T. 29 S., R. 14 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
