a tributary of Willamette River irrigation of 329.0 acres

for the purpose of

under Permit No. 6-7376 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 23, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.11 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEW NEW, as projected within Stevenson DLC 65, SEW SW4, Section 22, NEW NW4, Section 27, T. 6 S., R. 3 W., W.M.; Well No. 3 - 1380 feet North and 1100 feet West from the C4 Corner, Section 22; Well No. 6 - 930 feet North and 1140 feet West; Well No. 5 - 20 feet South and 1160 feet West both from the S4 Corner, Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
