CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROBERT C. NIEHUS

of 3797 Ray Bell Road NE, St. Paul , State of Oregon 97137 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River and Willamette Basin Project reservoirs constructed under Permits No. R-1625 and R-5363

a tributary of Columbia River for the purpose of irrigation of 39.0 acres and supplemental irrigation of 151.0 acres

under Permit No. 42523 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 19, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.5 cubic foot per second from the Willamette River and 325 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NE4, Section 31, T. 3 S., R. 2 M., W.M.; 1320 feet North and 20 feet East from the C4 Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permits No. R-1625 and R-5363 and is subject to the terms and conditions of contract No. 14-06-100-8054, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
