CERTIFICATE OF WATER RIGHT

of Route 2, Heppner , State of Oregon 97836 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Sand Hollow Creek for the purpose of irrigation of 548.9 acres and supplemental irrigation of 36.7 acres

under Permit No. G-4255 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 25, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.44 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW4 SW4, NE4 SW4, Section 26, T. 1 N., R. 26 E., W.M.; 2600 feet South and 30 feet East, 420 feet South and 1400 feet East, both from the W4 Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
