## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

VERN RATZLAFF

of 15301 Airlie Rd., Monmouth , State of Oregon, 97361 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed drainageway and reservoir constructed under Permit No. R-5928

a tributary of Little Luckiamute River stock and irrigation of 15.1 acres

for the purpose of

under Permit No. 36606 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 12, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second, being 0.01 c.f.s. for stock and 0.15 c.f.s. for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE_4$ , as projected within D. Lewis DLC 55, Section 18, T. 9 S., R. 5 W., W. M., 1300 feet South and 770 feet East from the NW Corner, J. Lewis DLC 54

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5928,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

In processing the application towards issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water per acre. In the issuance of this certificate, the rate of water has been

to not exceed 1/40th of one cubic foot per second per acre and  $2\frac{1}{2}$  acre feet reduced to 1/80th cubic foot per second per acre and  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of the proper maximum limits.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
