## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GALE MERWIN

of Paulina , State of Oregon, 97751 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Watson Creek and Watson Reservoir constructed under Permit No. R-5707

a tributary of Crooked River for the purpose of irrigation of 85.3 acres and supplemental irrigation of 620.1 acres

under Permit No. 35497 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 27, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 10.0 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN4 NN4, Section 28; SN4 NE4, Section 29; SE4 SN4, Section 32, T. 16 S., R. 22 E., W.M., SN4 NE4, Section 6, T. 17S., R. 22 E., W.M., Reservoir-480 feet South and 20 feet East; Diversion Point No. 1-2070 feet South and 1640 feet West, both from the NE Corner, Section 29; Diversion Point No. 2-1260 feet North and 2050 feet East; Diversion Point No.  $\star$ 

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5707, provided further that the right allowed herein shall be subject to the installation of a means of measuring the quantity of water released into Crooked River and the quantity rediverted from the river.

conform to such reasonable rotation system as may be ordered by the proper state officer.
