CERTIFICATE OF WATER RIGHT

This Is to Certify, That

, State of Oregon, 97751 Paulina proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Crooked River and Merwin Reservoir constructed under Permit No. R-2591

a tributary of Deschutes River for the purpose of irrigation of 91.4 acres and supplemental irrigation of 99.1 acres

under Permit No. 27249 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 1, 1961 for 3.0 c.f.s. and February 15, 1961 for 0.35 c.f.s. that the amount of water to which such right is entired and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.35 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{2}$, NE $\frac{1}{2}$, Section 16; NW $\frac{1}{4}$, Sw $\frac{1}{4}$, Section 5, T. 17 S., R. 22 E., W. M., River-410 feet South and 1170 feet West from the NE Corner, Section 16; Reservoir-1490 feet North and 210 feet East from the SE Corner, Section 6

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2591; the right allowed hereunder for the appropriation of water for lands having a valid prior right shall be limited to the amount necessary to make up any deficiency in water available to said lands under said prior right, and the amount allowed herein together with the amount secured under any other right existing for * ar conform to such reasonable rotation system as may be ordered by the proper state officer.
