CERTIFICATE OF WATER RIGHT

This Is to Certify, That LOIS AND HARRY WESLEY

of Route 2 Box 998, Roseburg, State of Oregon 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Umpqua River

a tributary of Pacific Ocean
irrigation of 14.6 acres

for the purpose of

under Permit No. 20675 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Grubb DLC 59, Section 18, T. 26 S., R. 6 W., W.M., 400 feet North and 1820 feet East from the SW Corner, Section 18

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows: Lots 1 and 2 Block 3, Plat "A" Roseburg Home Orchard Tracts in Section 18 and 19, T. 26 S., R. 6 W., W.M., Douglas County, Oregon.


This certificate is issued to supersede certificate of water right recorded at page 45751, Volume 38, State Record of Water Right Certificates so as to correctly describe the place of use and point of diversion.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
