## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** FRED SCHARER

of 10023 Selah Springs Rd. NE, Silverton, State of Oregon 97381, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Pudding River for the purpose of irrigation of 46.6 acres

under Permit No. G-6641 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 13, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.58 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within T. Shaw DLC 51, Section 7, T. 7 S., R. 1 W., W.M., 860 feet North and 620 feet East from the SW Corner, T. Shaw DLC 51

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

16.4 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
 3.3 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
 2.4 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$   
 18.2 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$   
 all as projected within T. Shaw DLC 51  
 1.8 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
 0.7 acre NE $\frac{1}{4}$  SE $\frac{1}{4}$   
 3.8 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$   
 all as projected within G. Shaw DLC 50  
 Section 7
