that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed $1\frac{1}{2}$ acre feet per acre in any 30 day period prior to June 1, 1 acre foot per acre in any 30 day period after June 1, of each year, or 3 acre feet per acre during any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre The point of diversion is located in the SW4 NE $\frac{1}{2}$, Section 35, T. 24 S., R. 36 E., W.M., Spurlock Ditch - 1530 feet South and 1930 feet West from the NE Corner, Section 35,
