of Route 8 Box 575, Salem , State of Oregon 97301 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coon Creek

a tributary of Willamette River irrigation of 8.8 acres

for the purpose of

under Permit No. 17239 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 19, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $_4$ SW $_4$, as projected within C. Hosford DLC 65, Section 8, T. 7 S., R. 3 W., W.M.; 1950 feet North and 525 feet East from the SW Corner, Section 8

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right herzby confirmed, and to which such right

is appurtenant, is as follows:

Land on which water is to be used is a part of that described as follows: Beginning at a point 18.55 chains South of the NW Corner of the C. Hosford DLC 65, thence South 16 chains, thence East 17 chains, thence North 8.5 chains more or less to the county road then Northwesterly along said road to the place of beginning within Section 8, T. 7 S., R. 3 W., W.M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 21166, Volume 15, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on October 26, 1979, approving transfer application No. 4273.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
