CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL SCHANNO

of Route 3, Box 23, The Dalles, State of Oregon 97058, has
 a right to the use of the waters of Fifteenmile Creek

a tributary of Columbia River for the purpose of
 irrigation of 60.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
 Wasco County, and the said decree entered of record at Salem, in the Order Record of
 the WATER RESOURCES DIRECTOR, in Volume 7, at page 406; that the priority of the
 right thereby confirmed dates from March 4, 1861

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
 amount actually beneficially used for said purposes, and shall not exceed three acre feet per
 acre in any irrigation season

The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 32, T. 1 S., R. 13 E., W.M.;
 2290 feet South and 1300 feet West from NE Corner, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 32

A description of the place of use under the right, and to which such right is appurtenant, is as
 follows:

15.1 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
 11.5 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
 20.7 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
 13.2 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 32
 T. 1 S., R. 13 E., W.M.


This certificate is issued to confirm the change in point of diversion approved
 by an order of the Water Resources Director entered April 16, 1973 and to cor-
 rectly describe the place of use as provided in the Wasco County Circuit Court
 Order Correcting Decree dated June 30, 1978 and together with certificate of
 water right recorded at page 39608, Volume 31, State Record of Water Right
 Certificates supersedes certificate of water right recorded at page 5666,
 Volume 6, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the
 water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree.
 The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
 use herein described.
