## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** WILLIAM J. AND GENEVIEVE M. BELAKIN

of 1508 Rogue River Hwy, Gold Hill, State of Oregon 97525, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 0.6 acre

under Permit No. 8888 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October, 16, 1916

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.007 cubic foot per second, if available at the original point of diversion, NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 11, T. 36 S., R. 3 W., W.M., North 38 degrees East 4900 feet from the SW Corner, Section 11

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE $\frac{1}{4}$  SW $\frac{1}{2}$ ) Section 24, T. 36 S., R. 4 W., W.M., 1000 feet South and 650 feet West from the Center of Section 24

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


0.6 acre Lot 3 (NE $\frac{1}{4}$  SW $\frac{1}{2}$ )  
Section 24  
T. 36 S., R. 4 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 7, 1976, together with certificates of water right recorded at pages 48918, 48879, 48915, and 48880, Volume 42, State Record of Water Right Certificates and an order of the Water Resources Director entered March 7, 1977 supersedes certificate of water right recorded at page 10956 Volume 10, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
