## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GEORGIA BELLE HOLZAPFEL

of PO Box 214, Wasco , State of Oregon 97065 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells No. 3, No. 4 and No. 5

a tributary of Columbia River for the purpose of irrigation of 111.0 acres and supplemental irrigation of 159.4 acres

under Permit No. G-1625 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 28, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.08 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE¼ NE¼, NW¼ NE¼, NE¼ NW¼, Section 32, T. 4 N., R. 27 E., W.M.; Well No. 3 - 360 feet South and 1220 feet West; Well No. 4 - 50 feet South and 1450 feet West; both from the NE Corner, Section 32; Well No. 5 - 70 feet South and 2520 feet East from the NW Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year. The total appropriation of water from Well No. 5 shall be further limited to 575 gallons per minute (1.28 cubic feet per second) as established under permits numbered U-523, U-524 and U-750

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
