under Permit No. 10842 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 30, 1933

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second, if available at the original point of diversion; NE $\frac{1}{2}$ SW $\frac{1}{4}$, Section 10, T. 5 S., R. 3 E., W.M., 2850 feet South and 1700 feet East from the NW Corner, Section 10

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\,$ NW4, Section 3, T. 5 S., R. 3 E., W.M., 1000 feet South and 880 feet East from the NW Corner, Section 3

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

Certificate of water right recorded at page 48219, Volume 41 State Record of Water Right Certificates was issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered August 11, 1966, and together with the remaining right certificate of water right recorded at page 48218, Volume 41 State Record of Water Right Certificates superseded certificate of water right recorded at page 27923, Volume 20 State Record of Water Right Certificates. A clerical error was made in describing the remaining right as recorded at page 41, Volume 48218 rather than page 48218, Volume 41.

This certificate is issued to correctly describe the page and volume numbers of the remaining right certificate and supersedes certificate 48219.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.
