under Permit No. G-2823 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.23 cubic feet per second

or its equivalent in case of rotation measured at the point of diversion from the well. The well is located in the SE½ SE½, Section 30, T. 4 N., R. 27 E., W.M.; SE½ NE½, Section 4, T. 3 N., R. 27 E., W.M.; Well No. 1 - 290 feet North and 50 feet West Well No. 2 - 100 feet North and 40 feet West; both from the SE Corner, Section 30, T. 4 N., R. 27 E., W.M.; Well No. 3 - 1970 feet South and 790 feet West from the NE Corner, Section 4, T. 3 N., R. 27 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
