CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONALD SMITH

of Wild River Drive, Roseburg , State of Oregon 97470 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Umpqua River

a tributary of Umpqua River irrigation of 0.6 acre

for the purpose of

under Permit No. 27896 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second if available at the original point of diversion, NW_4 SW_4 , as projected within R. Foster DLC 43, Section 13, T. 26 S., R. 4 W., W.M.; 2300 feet North and 20 feet East from SW Corner, Section 13

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within R. Foster DLC 43, Section 14, T. 26 S., R. 4 W., W.M.; 2300 feet North and 130 feet West from SE Corner, Section 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the use of water from North Umpqua River is limited to the period when the flow of said river is more than 525 cubic foot per second measured at its mouth;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre NE¼ SE¼ as projected within R. Foster DLC 43
Section 14
T. 26 S., R. 4 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered July 28, 1969 and supersedes certificate of water right recorded on Page 33411, Volume 25, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
