CERTIFICATE OF WATER RIGHT

This Is to Certify, That TED OSBURN

of Kellogg Route, Box 80 E, Oakland , State of Oregon 97462 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Umpqua River

a tributary of Pacific Ocean irrigation of 0.7 acre

Permit A-3M-1-76

for the purpose of

under Permit No. 25778 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second, if available at the original point of diversion, Lot 1 (SE4 SW4) Section 2, 620 feet North and 1420 feet East, 40 feet North and 2250 feet East; both from SW Corner, Section 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NW4 NE4) Section 11, T. 24 S., R. 7 W., W.M.; 1000 feet South and 2920 feet East from NW Corner, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of water in the Umpqua River is 525.0 c.f.s. or more at tidewater

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre Lot 1 (NE¼ NW¼) 0.6 acre Lot 1 (NW¼ NE⅓) Section 11 T. 24 S., R. 7 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 5, 1978 and together with certificate of water right recorded on Page 46546, Volume 39, State Record of Water Right Certificates and an order of the Water Resources Director entered September 5, 1978 supersedes certificate of water right recorded on Page 44046, Volume 36, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
