CERTIFICATE OF WATER RIGHT

This Is to Certify, That LEO L. AND CLARA C. FLOWER

of Route 3 Box 3746, Hermiston, State of Oregon 97838, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Fork John Day River

a tributary of John Day River for the purpose of irrigation of 30.9 acres

under Permit No. 39980 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 9, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.77 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 2, T. 9 S., R. 27 E., W.M.; 2320 feet South and 1550 feet East from NW Corner, Section 2

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.7 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
 3.9 acres Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
 1.3 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
 2.5 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
 6.3 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$


