of 7185 Crowfoot, Trail , State of Oregon, 97541 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 31.0 acres

for the purpose of

under Permit No. 8572 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1928

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.39 cubic foot per second, if available at the original point of diversion, Dennis, Johnson and Hall Ditch - SE½ SE½, Section 16, T. 34 S., R. 1 W., W.M., 1320 feet North and 80 feet West from the SE Corner, Section 16

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (SW_4 NE $_4$) Section 28, T. 34 S., R. 1 W., W.M., 780 feet North and 450 feet East from the Center, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.0 acres Lot 1 (NE¼ NE¼)
16.0 acres Lot 1 and Lot 7 (SE¼ NE¼)
Section 28
T. 34 S., R. 1 W., W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 15, 1976, and together with certificate of water right recorded at page 43989, Volume 36, State Record of Water Right Certificates together with an order of the Water Resources Director entered September 15, 1976, supersedes certificate of water right recorded at page 10541, Volume 10, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
