CERTIFICATE OF WATER RIGHT

of Route 1, Box 246, Turner , State of Oregon 97392 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of North Santiam River irrigation of 36.7 acres

for the purpose of

under Permit No. G-4776 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 31, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second, being 0.02 c.f.s. from Well No. 1, 0.22 c.f.s. from Well No. 2, and 0.21 c.f.s. from Well No. 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 3 (NE4 SW4), SW4 SW4, Section 26, Lot 1 (NW4 NW4), Section 35, T. 9 S., R. 2 W., W.M., Well No. 1 - 630 feet South and 1720 feet East, Well No. 2 - 2190 feet South and 1040 feet East, Well No. 3 - 2820 feet South and 1330 feet East, all from NE Corner, Chamness DLC 59

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed \mathbb{Z}_2 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
