under Permit No. G-7932 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 14, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.83 cubic foot per second, being 0.57 c.f.s. from Well No. 1 and 0.26 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within McKinney DLC 55, Section 4; Lot 6 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 9, T. 10 S., R. 2 W., W.M.; Well No. 1-250 feet North and 1940 feet East, Well No. 2-1760 feet South and 1250 feet East, both from the NW Corner, Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.
