CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Box 96, Redmond , State of Oregon 97756 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Dairy Creek

a tributary of Tualatin River irrigation of 34.5 acres

for the purpose of

under Permit No. 14050 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 9, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, Section 1, T. 1 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described as follows: Commencing on the Base Line at a point 50 links East of the NW corner of the NE% Section 1, T. 1 S., R. 3 W., thence West on the Base Line 27.25 chains; thence South 25 degrees West 16.13 chains; thence South 30 degrees 31 minutes East 20.31 chains; thence East 23.76 chains; thence North 32.30 chains to the place of beginning, containing 95.36 acres, in Washington County, Oregon.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 16653, Volume 13, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on December 20, 1979, approving transfer application No. 4308.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
