CERTIFICATE OF WATER RIGHT

This Is to Certify, That ESTATE OF ADDISON L. TULLEY, Jesse E. Tulley, Adm.

of Wallowa , State of Oregon , has a right to the use of the waters of Wallowa River, a tributary of the Grande Ronde River, and the South Fork of Wallowa River,

a tributary of Wallowa River for the purpose of the irrigation of 259 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5 , at page 197; that the priority of the right thereby confirmed dates from 1907 for Tracts 1 and 2; 1900 for Tract No. 3, May 1893 for Tract No. 4 and 1897 for Tract No. 5 that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season.

The point of diversion is located in the Master-son Tulley SW\(\frac{1}{4}\) Section 21; Tulley No. 2 SE\(\frac{1}{4}\) NE\(\frac{1}{4}\), Section 19; Tulley-Hill SE\(\frac{1}{4}\) Section 20; Standley Tulley Storey (Wallowa Irrigation Company) SW\(\frac{1}{4}\) NW\(\frac{1}{4}\), Section 20; Tulley No. 1 SW\(\frac{1}{4}\) NW\(\frac{1}{4}\), Section 20; Township 1 North, Range 43 East of Willamette Meridian.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
