## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** CARL F. AND VIRGINIA R. FISCHLE

of Route 1 Box 40 A, Riddle, State of Oregon 97469, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Russell Creek

a tributary of Cow Creek for the purpose of irrigation of 5.0 acres

under Permit No. 35166 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 27, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second, water to be diverted from Russell Creek when available with any deficiency in the available supply from Russell Creek to be made up by diversion from Cow Creek provided that the total quantity diverted from \* or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Wilson DLC 41, Section 34, T. 30 S., R. 6 W., W.M.; Russell Creek - 1660 feet South and 3700 feet East; Cow Creek - 700 feet South and 2420 feet East from the NW Corner Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


0.1 acre NW $\frac{1}{4}$  NE $\frac{1}{4}$   
4.5 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.4 acre SE $\frac{1}{4}$  NW $\frac{1}{4}$   
all as projected within Wilson DLC 41  
Section 34  
T. 30 S., R. 6 W., W.M.

\* both sources shall not exceed 0.06 c.f.s.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
