## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** VOYLE E. AND FRANCES CHANEY

of Box 199, S. Myrtle Route, Myrtle Creek, State of Oregon 97457, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Myrtle Creek

a tributary of South Fork Umpqua River for the purpose of irrigation of 2.8 acres

under Permit No. 4380 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 9, 1920

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.035 cubic foot per second, if available at the original point of diversion, SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 30, T. 29 S., R. 4 W., W.M.; 1800 feet South and 250 feet West from the NE Corner, Section 30

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 30, T. 29 S., R. 4 W., W.M.; 1190 feet North and 900 feet West from the E $\frac{1}{4}$  Corner, Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered November 15, 1978 and together with certificate of water right recorded at Pages 49163, 49164, 49165, and 49166, Volume 42, State Record of Water Right Certificates, and together with orders of the Water Resources Director entered November 15, 1978, supersedes certificate of water right recorded on Page 5594, Volume 6, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.*
