that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.033 cubic foot per second, if available at the original point of diversion, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 30, T. 29 S., R. 4 W., W.M.; 1800 feet South and 250 feet West from the NE Corner, Section 30

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NE4, Section 30, T. 29 S., R. 4 W., W.M.; 1350 feet South and 1230 feet East from the N4 Corner, Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
