## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Route 4, Box 590, Roseburg , State of Oregon 97470 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Lookingglass Creek

a tributary of South Umpqua River irrigation of 29.1 acres

for the purpose of

under Permit No. 20558 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 13, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4 and SW4 NW4, as projected within Todd DLC 39, Section 12, T. 28 S., R. 7 W., W.M.; 1180 feet South and 610 feet East, 2300 feet South and 420 feet East, both from NW Corner, Section 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
