CERTIFICATE OF WATER RIGHT

This Is to Certify, That CREIGHTON BAXTER, JR.

of Route 1, Box 120, Oakland, State of Oregon 97462, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Calapooya Creek

a tributary of Umpqua River for the purpose of irrigation of 59.0 acres

under Permit No. 19857 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 22, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.74 cubic foot per second, if available at the original point of diversion, NE 1/4 SE 1/4 as projected within Green DLC 41, Section 34, T. 24 S., R. 5 W., W.M.; 520 feet South and 740 feet West from the E 1/2 Corner, Section 34

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, Section 35, T. 24 S., R. 5 W., W.M.; 4430 feet North and 4080 feet East from the SW Corner, Section 35

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.7 acres NE 1/4 NE 1/4
- 3.5 acres NW 1/4 NE 1/4
- 13.8 acres SW 1/4 NE 1/4
- 36.0 acres SE 1/4 NE 1/4
- 1.2 acres NE 1/4 SE 1/4
- Section 35
- 1.8 acres SW 1/4 NW 1/4
- Section 36
- T. 24 S., R. 5 W., W.M.

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered July 14, 1976, and supersedes certificate of water right recorded at Page 24527, Volume 17, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
