that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.66 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, Section 3, T. 11 S., R. 2 W., W.M.; 3550 feet South and 2170 feet West from NE Corner, SE4 NW4, Section 3
