a tributary of Sand Hollow Creek $\,$ for the purpose of irrigation of 18.6 acres and supplemental irrigation of 19.0 acres

under Permit No. G-541 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 29, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW4 SE4, Section 1, T. 1 S., R. 26 E., W.M.; 550 feet North and 1900 feet West from the SE Corner, Section 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
