## CERTIFICATE OF WATER RIGHT

of Route 3, Box 393-A, Corvallis , State of Oregon 97330 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a channel of the Willamette River

a tributary of Columbia River irrigation of 52.8 acres

for the purpose of

under Permit No. 35771 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 3, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.66 cubic foot per second, if available at the original point of diversion; Lot 10 ( $NW_4$   $NE_4$ ), Section 31, T. 12 S., R. 4 W., W.M.; 3290 feet South and 40 feet East from the Center, Section 30

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SW4 NE4), Section 31, Lot 6 (SE4 SW4), Section 30, T. 12 S., R. 4 W., W.M.; Diversion No. 4 - 2790 feet North and 2580 feet East from SW Corner, Section 31; Diversion No. 2 - 2060 feet South and 690 feet West from C4 Corner, Section 31

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
